## Civil Society organizations



## Multilateral System

- A bold and forward-looking **CSW69 Political Declaration** is adopted
- **CSW is revitalized** to strengthen the implementation of Beijing PfA and SDGs
- The Secretary-General’s **Gender Equality Acceleration Plan** is implemented by all UN entities
