La aprobación del Plan Nacional de Adaptación al Cambio Climático (2021-2030) en 2020 supone la integración de la perspectiva de género en el principal instrumento estratégico para la adaptación al cambio climático de escala nacional. Este plan incluye 7 aspectos transversales entre los que se encuentra la integración de la perspectiva de género en la acción climática. A través de este plan y de sus programas de trabajo quinquenales se impulsan medidas para la recogida de datos desagregada por sexos y el desarrollo de indicadores específicos para entender las desigualdades por razón de género y favorecer la adaptación con perspectiva de género; la consideración de las diferencias de género en cuanto al acceso a la información y formación; la consideración de las mujeres como agentes de cambio favoreciendo su acceso a posiciones de liderazgo, entre otras cuestiones. En este contexto se desarrolló en 2021 el estudio Riesgos climáticos desde la perspectiva de género: percepción, posicionamiento y adaptación en mujeres y hombres que constituye el primer diagnóstico con enfoque de género frente a los riesgos de desastres por consecuencias climáticas y su impacto en la población. El trabajo, liderado por el Instituto de las Mujeres, analiza las posibles brechas de género en cuanto a la percepción del riesgo, el nivel de información, el conocimiento, la preocupación y las medidas de adaptación y mitigación frente al cambio climático adoptadas por mujeres y hombres.
