

WYDE | Women's Leadership UN Women Call for Proposals

FAQ revised: 4 November 2024

- 1. Clarification requested on whether civil society organisations not registered with the Generation Equality Action Coalition on Feminist Movements and Leadership are still eligible to apply. Is it an incentive or a requirement to be a commitment maker in the Generation Equality Action Coalition on Feminist Movements and Leadership**

All civil society organizations are eligible to apply if they meet the requirements. The organizations that will pass the selection process will be encouraged to join the Generation Equality Action Coalition on Feminist Movements and Leadership if they are not already commitment makers at the time of application.

Applications will be appraised based on their eligibility and ability to meet the requirements and produce the intended results. Organizations are encouraged to be members of the Generation Equality Action Coalition on Feminist Movements and Leadership.

- 2. Could you kindly provide guidance on how to become a member and commitment maker for UN Women's Generation Equality Action Coalition on Feminist Movements and Leadership?**

Regardless of the call for proposals, interested organisations can follow these steps to becoming a commitment maker in the Generation Equality Action Coalition on Feminist Movements and Leadership:

- Fill out the **Expression of Interest Form**:

- Complete the **Commitment Making Form**, which will be shared with the organization by UN Women after confirming the expression of interest.
- The commitments are made under the 4 action areas of the AC outlined in the Global Acceleration Plan : <https://commitments.generationequality.org/sites/default/files/2022-09/UNW-GAP-Report-EN-web.pdf>
- Review and finalize the form with the thematic lead's support – the organization will be informed how to make this connection by UN women.
- Submit the finalized form through the **online portal**, which will be provided.

- 3. Can global networks apply if they are not registered in the country of implementation? Can organizations apply if they are not based in the country of implementation?**

Lead organizations must have an office in the country in which they will implement the project.

5. Are collaborations encouraged under the terms of the call for proposals? Where can relevant organizations who are commitment makers to the Feminist Movements and Leadership Action Coalition be found?

6. What countries are eligible?

7. Does the organization need to have financial statements for the last three years?

Yes, the lead organization must have certified annual financial statements for the previous three years.

8. Can all the consortium members submit Annex B-3?

It is not necessary to have all sub-partners submit resumes of all personnel, but you may submit them as long as they are differentiated from the lead applicant organization.

9. Who will write the CFP letter for responsible parties and proposal data sheet for Responsible Parties, Is it the Proponent or UN Women?

Section 1, which includes parts a. the CFP letter for responsible parties and b. the proposal data sheet, were prepared by UN Women. Section a. notes which documents need to be completed and returned by the proponent.

10. Can an organisation apply as a sub partner in multiple proposals or is this limited to one?

An organization may apply as sub-partners according to their own internal capacity. UN Women will conduct NGO capacity assessments as part of the final award process, should an applicant make it to the final stages. An organization must make their absorptive capacity assessments for their own organizational capabilities.

11. Should all documents be submitted before the deadline?



Yes, all documents should be sent to WYDE@unwomen.org before the submission deadline of 11 November. Any missing documents from the mandatory list of requirements would lead to disqualification.
