PERFORMANCE HIGHLIGHTS IN 2023

Most significant gains


- UNICEF exceeded the requirements for seven indicators and met them for another nine indicators.
- Significantly in 2023, the entity newly exceeded the Reporting on Gender-Related SDG Results indicator.
- The entity made notable progress by newly meeting the requirements for Equal Representation of Women indicator.

Areas for improvement

- UN Women encourages UNICEF to focus on the remaining indicator rated as approaching requirements: Capacity Development.
- UN Women also encourages UNICEF to recapture the lost progress on two indicators: Evaluation and Financial Resource Allocation.

PERCENTAGE OF RATINGS MEETING/EXCEEDING REQUIREMENTS (NOT APPLICABLE RATINGS OMITTED)




In both 2018 and 2023, UNICEF maintained a strong performance that was significantly above the averages of both the Funds and Programmes and the overall UN System.

COMPARISON OF RATINGS WITHIN THE UN SYSTEM, 2023



In 2023, UNICEF met more indicators than the average for Funds and Programmes and the overall UN system, though it exceeded slightly fewer than similar entities. UNICEF did not miss any indicators and assessed all indicators applicable.

COMPARISON OF RATINGS BY YEAR, ENTITY SPECIFIC, 2018-2023



From 2018 to 2023, UNICEF sustained solid progress by "exceeding" and "meeting" a greater proportion of indicators.

In 2023, the entity improved as one more indicator shifted from "approaching" to "meeting" requirements, though fewer indicators were rated as "exceeding" requirements compared to 2022.
