WOMEN Background

- Haiti ranks 138 out of 155 countries in the Gender Inequality Index (GII), reflecting serious disparities in wellbeing, opportunities, access and control over productive resources seriously impeding Haiti's prospects of ensuring equal opportunities between women and men.
- Feminization of poverty and acute gender gaps in service delivery: Around 44 % of Haitian families are female headed households and women represent the majority of persons living in extreme poverty, and occupy the bottom rungs of the economically active labor force.
- Extremely low levels of women's participation in decision making: Despite women constituting approximately half of the electorate, women in Haiti have extremely low participation in the decision-making and representation at almost all levels of governance. Currently 1/30 senators and 3/99 congresswomen in the Parliament.
- Violence against women and girls is routinized and reinforced by norms and attitudes





Key changes in context and programme over 2017

- New 2018 -2021 Strategic Note has been approved
- Swearing-in of new President, cabinet following an election re-run held after an 18-month political gridlock resulting from contested Presidential elections held in 2015.
- UN Mission drawdown and a shift in emphasis in the approach by the UN towards stabilization in Haiti from a 'technical' (i.e. traditional peacekeeping) to a 'political' (i.e. rule of law institutions, good offices) focus.
- New strategic political and strategic directions provided by: new UNDAF, first National Gender Policy framework and the 10 year National EVAW Plan.
- Sustained commitment and levels of engagement by international partners, though with a pronounced emphasis on exploring new and different approaches and national partners and coalitions.

Three Sources of Growth

- Innovative approaches to institutional strengthening in support of gender mainstreaming (first comprehensive capacity development and support plan developed for Ministry of Women Affairs with the support of UNW; capitalization of this plan already started and Unit gender models being put in place in key public entities to ensure gender mainstreaming at all levels)
- Closing gender gaps in agricultural productivity and service delivery (About 44 % of families are female headed and women represent the majority of persons living in extreme poverty while being the backbone of the economy. They receive low and unreliable profits from agriculture due to weak infrastructure, poorly defined land tenure and lack of access to credit)





Three Sources of Growth (2)

Investment conduit for partners looking to invest in integrated approaches to the attainment of big gender equality results (technical expertise and knowledge of the field, integrated approach for intervention and leadership in the coordination of technical and financial partners working in gender equality, including UN agencies)

Political representation at local **level.** The political combo for the municipal assembly 3 local candidates: 2 male and one female, invariably. This mechanism was conceived to increase the number of women political representative at municipal level. Today Haiti is the country with the highest political participation at municipal level 33.3% of whole LAC region.



The experimental farm Delicia Jean

Multiplication effect/ Tot approach: 240 women certified by the Haitian Professional Training Institute (INFP) and 1,500 men and women trained by these accredited trainers

New and non-traditional markets/resilient agriculture: Production of moringa and other market good

Innovative approaches: Buy from women platform


