THE EXECUTIVE BOARD ROLES AND RESPONSIBILITIES



- The EB *role* is set within the overall framework of policies formulated by the General Assembly, and the Economic and Social Council.
- The EB functions are:
 - Receive information from and give guidance to the Executive Director
 - Oversee the Entity operational and coordination activities
 - Approve UN-Women overall governing documents:
 - Strategic Plan, Integrated Budget, audit reports, evaluation plans and policies; and other managerial and policy documents.
 - Provide inter-governmental support to UN-Women leadership

THE EXECUTIVE BOARD MEMBERSHIP



Who are the EB members?

41 members across regions & donors who serve on a rotating basis:

- 10 from the Group of African States
- 10 from the Group of Asia-Pacific States
- 4 from the Group of Eastern European States
- 6 from the Group of Latin American and Caribbean States
- 5 from the Group of Western European and Other States (unique rotation scheme)
- 6 from contributing countries

Each member is elected by the Economic and Social Council for a term of three years.


