# Despite numerous instances of formal recognition & progress made, equality in daily life is still not a reality in Moldova

- 20% of the electorate mention they wouldn't vote for a woman leader
- The majority of sector strategies, plans and budgets are developed and implemented without taking into the account the gender perspective
- 63% of women experience psychological, physical, or sexual violence by a husband or partner.
- 1 in 10 women experienced economic violence at least once





# How Core Funding brings change

#### **Core Funding**

- Accelerate normative change towards gender equality
- Front loads programming that supports member states achieve their development ambitions
- Funds accountability and oversight
- Funds UN Women's presence where its needed most (in countries with a high level of inequality but a low availability of donor funding)

UN Women's Moldova country programme is focused on three national gender equality priorities

- Leadership and political participation
- Ending violence against women
- Economic empowerment

#### **WOMEN IN POLITICS**



WIP: The Women in Politics programme supports the increased participation of women in politics and in the decision-making process by creating an environment conducive to their meaningful participation, and to support capacity development of women before, during, and after the elections at the central and local levels.

This project was a **joint effort between UN**Women, UNDP, and civil society to assist
Government of Moldova in addressing critical challenges.

The budget for this project was \$3,485,690 from the Government of Sweden

Following the implementation, UN Women worked with various partners to raise awareness of the numerous provisions in the group

### WiP results

- 1. WiP supported a legislative package adopted as Law 71 in May 2016. Law 71 amended 15 national laws across the Electoral Code, Law on Government and Labor Code of Republic of Moldova, including;
- Adoption of the 40% quota for representation of either gender on the candidates lists of political parties for Parliamentary and local elections.
- 40% quota for representation of either gender in political party management structures
- Introduction of a 14 day paid paternity leave to be financed by the State Insurance Fund
- 40% quota for representation of either gender in the Audiovisual Council
- Defining sexism and providing sanctions for use of sexist language and images on media advertising
- Complementing the existing responsibilities and structures on gender equality units at the national and local levels.



## **Human Story**

Varvara Duminica is one of the first two Roma women elected as councilors in Moldova. A trained kindergarten teacher, principal and methods specialist, Ms. Duminica has long worked on social projects, specifically with the Roma community.

Through the Women in Politics program, UN Women invited a Romanian Roma woman, Letitia Marc, to visit several localities in Moldova and speak to the women about proposing their candidacy in the upcoming elections. As a result of her encouragement, Ms. Duminica stepped forward.



Her goal is to integrate Roma people in the Moldovan society as much as possible and it was this connection which **led to her successful run for office in 2015.**
