<u>Take five: "Nothing about disability should be done without women with disabilities"</u> Date: Thursday, June 14, 2018

Renowned disability rights activist, Ana Peláez Narváez, from Spain, is the first woman with disability to be elected to the UN Committee on the Elimination of Discrimination against Women (CEDAW Committee) on 7 June, 2018. More



In the words of Nidhi Goyal: "These spaces belong to everyone"

Date: Wednesday, June 13, 2018

Nidhi Goyal, 32, is a disabled feminist from India who works on disability rights and gender equality. After losing her sight as a teenager, Goyal committed herself to changing the lives of persons with disabilities, and particularly women and girls with disabilities. As a researcher, writer, trainer, stand-up comedian and advocate, she works to raise awareness on the intersection of the disability rights movement, and the women's movement. More



In the words of Jana Mustafa: "Disability should not stop anyone from starting over"

Date: Tuesday, November 14, 2017

Jana Mustafa is a former employee of an international NGO and a survivor of violence. She lost her job due to an abusive marriage and experienced years of physical and psychological violence. She got a divorce with the legal help of the Hayat Centre in the Gaza Strip. More



# In the words of Elena Kochoska: "Women bear a double burden because of their gender and disability"

Date: Tuesday, July 11, 2017

Elena Kochoska is a vocal advocate for persons with disabilities in the former Yugoslav Republic of Macedonia and works at the local organization, Polio Plus, Movement Against Disability. She participated in training and mentoring sessions on gender-responsive budgeting (GRB)—analyzing a budget to ensure women's needs are met—organized by UN

Women's regional programme on GRB, supported by the Swiss Agency for Development and Cooperation and the Austrian Development Agency. Thereafter, she prepared a report that did a cost-benefit analysis showing the benefits of including children with disabilities in mainstream education. More



### In the words of Ndèye Daro Niang: "I am a valued member of my community"

Date: Tuesday, August 16, 2016

Ms. Niang is one of 213 women with disabilities who have benefited from the Gender Equitable Local Development programme implemented by UN Women in 58 local councils in Senegal, with financial support from Luxembourg. Through workshops and information sessions, women with disabilities have been sensitized and trained on Senegal's landmark social orientation law, adopted in 2010, and on addressing the unique and specific needs of disabled women in menstrual hygiene management. More

The initiative ran from June to October 2017 and was part of the UN "Women in Politics" Programme, financed by the Government of Sweden. More

Casar Jacobson, a disability rights activist and a UN Women Youth Champion, shares her personal story of living with hearing disability and persevering to carve out a place in the world of work. She stresses on the power of technology in ensuring that no one is left behind. More

For Pratima Gurung from Nepal, empowering indigenous women with disabilities starts with making them count as active participants and decision-makers, not just observers of decisions. She points to the need to strengthen their voices in disability fora, as well as indigenous peoples' fora. More

## <u>Civil Society calls to leave no woman or girl in rural communities behind in the quest for gender equality</u>

Date: Friday, March 16, 2018

On the sidelines of the 62nd session of the UN Commission on the Status of Women (CSW62), UN Women, along with civil society partners\*, convened a dialogue with activists from rural areas and other allies. The conversation brought together diverse constituencies from around the globe to discuss what it would take to leave no woman or

girl in any rural area behind in the achievement of the Sustainable Development Goals. Participants included indigenous women, those living with disability, members of the LGBTI community, widows, refugees and migrants and youth activists, who highlighted the importance of including their needs in actions towards gender equality. # EU-UN Spotlight Initiative urges inclusive global action on violence against women and girls

On 12 March, opening day of the 62nd Session of the Commission on the Status of Women (CSW62), the Spotlight Initiative, a multi-year partnership between the European Union and the United Nations, brought together leaders from Government and civil society to discuss strategies for eliminating violence against women and

girls. Lizzie Kiama, an advocate from Kenya who said that women with disabilities were "10 times more likely to experience violence than women without disabilities." More
