Item 2

Statement by the Under-Secretary-General and Executive Director: report on country visits

Under this item, the Under-Secretary-General and Executive Director of UN-Women will make an oral presentation to the Executive Board in connection with the field visits she made during the first half of 2011.

Item 3 Strategic plan for 2011-2013

Under this item, the Executive Board will have before it the UN-Women strategic plan for 2011-2013. The plan was developed pursuant to paragraph 77 of General Assembly resolution 64/289 of 2 July 2010 on system-wide coherence. This is the first strategic plan of UN-Women and presents the context of the organization and its vision and priorities for gender equality and women's empowerment during its first years of existence. The strategic plan builds on the broad consensus that emerged from numerous consultations in favour of the priority areas outlined in the vision and 100-day action plan that the Under-Secretary-General and Executive Director presented to the Executive Board at its first regular session of 2011. The strategic plan brings to life the mandate of UN-Women to support countries in eliminating discrimination against women and girls, and places women's rights at the centre of all its efforts. To that end, the plan highlights the central role of UN-Women in ensuring a more coherent United Nations system response to advance gender equality throughout the world.

The plan focuses on six programmatic priorities: (a) to expand women's leadership and participation; (b) to end violence against women; (c) to strengthen

implementation of the women and peace and security agenda; (d) to enhance women's economic empowerment; (e) to make gender equality priorities central to national planning and budgeting at all levels; and (f) to support intergovernmental processes of the United Nations towards making commitments, norms, standards and policies on gender equality, the empowerment of women and gender mainstreaming more comprehensive and dynamic.

The Executive Board may wish to review and approve the strategic plan for 2011-2013 (to be issued as UNW/2011/9).
