HIV is a public health issue and a human rights concern. HIV drives gender inequality and impacts on the development of individuals and communities. Gender inequality and unequal power relations continue to significantly influence the epidemic. IPPF is a global service provider and leading advocate of sexual and reproductive health and rights (SRHR) for all. IPPF works with individuals and communities to address causes of inequality, reduce GBV, and challenge laws that deter the enjoyment and fulfilment of SRHR and empower women and girls. This session will include global experts on SRHR, HIV and gender. They will debate the proposed post-2015 global architecture to address gender inequality and empower individuals to exercise choice in their sexual and reproductive lives; take charge of their bodies and reduce the risk of HIV. The highlight of this session will be testimonies from young people living with HIV, survivors of gender-based violence and transgender people. Special Session No One Left Behind: Stepping Up the Pace on the Removal of Punitive Laws to Advance Human Rights and Gender Equality Monday, 21 July 2014 13:00-14:00 Location: Melbourne Room 1

Throughout the world, punitive laws and law enforcement practices continue to be barriers to effective HIV responses. Such laws and practices contribute to making individuals and specific populations more vulnerable to HIV and hinder their access to health and HIV services. Even in countries where protective laws have been introduced to support HIV responses and uphold the right of people living with HIV, women and girls, and key populations, their enforcement is often inappropriate and their impact remains limited. Responding to these concerns, the UNAIDS Strategy 2011-2015: Getting to zero as well as the 2011 Political Declaration on HIV called for laws and law enforcement that support effective HIV responses. In 2010-2012,

the Global Commission on HIV and the Law, conducted a review of laws and law enforcement practices globally and their impact on HIV responses, and issued bold recommendations for advancing human rights in the context of HIV. This session addresses the interface between violence towards women and HIV. It examines the range of violence directed towards women from intimate partners to health care workers. The symposium will highlight how culturally-condoned violence can lead to contracting HIV and how women living with HIV face disproportionate levels of violence in every sector of society. Violence is disproportionately directed towards women regardless of whether they are mothers, lovers, young or old, in the home or the hospital. The presenters each speak passionately from very different personal perspectives, and offer strategies to overcome the challenges women face. Abstract – Poster Exhibition and Presentation – Late Breaker Tuesday 22 July 2014, 12:30 –14:30 Location: Poster Exhibition Area Strengthening advocacy and policy-setting capacity of networks of Women living with HIV: lessons from a five-country programme evaluation **Background:** An evaluation was conducted of a five country program "Supporting Gender Equality in the Context of HIV/AIDS" to measure the effectiveness of the HIV response for women through strengthening of policy and planning frameworks and securing a greater voice for organizations/networks of women living with HIV and affected by HIV (WLHIV) in decision-making processes. One significant objective focused on WLHIV organizations providing leadership and influencing of policies, programmes, and resource allocations of the HIV response. Interventions focused on building the leadership capacity of women living with HIV through peer and training workshops and opportunities for advocacy at national, regional and international levels. Poster provides findings and learning from the evaluation.

Increasing access to property and inheritance rights of women living with and affected by HIV and AIDS in Sub-Saharan Africa: lessons from a nine country program

Background: Women in many sub-Saharan African countries have statutory rights to own property, however many experience patterns of discrimination in accessing and securing these rights as a result of norms and customary laws that reinforce gender inequalities. Women living with HIV and AIDS are particularly vulnerable to property and inheritance rights violations because of the stigma associated with HIV. They are often stripped of their assets and forcibly evicted from their lands and homes undermining their ability to access HIV treatment, care and support. Poster provides findings and lessons from work to address this issue.
