FUNDRAISING FACTSHEET



The Fund for Gender Equality (FGE) is UN Women's grant-making mechanism dedicated to the economic and political empowerment of women worldwide. **Since 2009 FGE has granted \$64 million to 120 programmes in 80 countries, impacting the lives of 10 million beneficiaries in developing countries.**

Active programmes in 2015 allowed for 77,000 women to participate in public fora to influence policies, including 228 new laws and policies adopted to protect women's rights, 13,000 women to gain sustainable income, and 17,000 to access productive resources such as land and credit.

Why what we do matters

Women-led civil society organizations (CSOs) know the realities on the ground and how to achieve change. Yet their expertise is often overlooked and underfunded. FGE is UN Women's tool to support and strengthen civil society's transformational capacity, without which **sustainable development** could not happen.



Who does all this

A dedicated team of passionate and experienced professionals including five **specialists** in UN Women Regional Offices, a **network of country Focal Points** and a **team based in HQ** coordinating global processes.



Why we are more than a financial instrument

The FGE is not only about providing funds to CSOs, but it also:

- **Strengthens** results-based management and reporting **capacities** of grantees
- **Monitors and provides guidance** for effectiveness and efficiency
- Produces **results-based global reporting annually** for accountability
- **Generates and communicates knowledge** from global portfolio for learning
- Fosters **grantee interaction** for learning and exchange
- Supports **independent evaluations** for accountability and improvement



How the money is spent

- **75%** of resources are invested directly into **grants**
- **11%** is devoted to **technical assistance** and day-to-day support to grantees
- **10%** to operations which include **grant-making, knowledge generation, evaluation and communications**
- **4%** goes to support costs as part of UN Women standard overhead

Why give to the FGE?

When you support the FGE, you:

- > **Get value for your money, creating tangible, high impact results for women and girls around the world.** On average, for every \$1 invested in the FGE, \$0.86 directly benefits CSOs.
- > **Advance learning and innovation.** FGE is never business as usual. Our commitment to quality and change-making drives us to embark on knowledge projects such as research initiatives, evaluations, and surveys. In 2017, we plan to pilot an innovation window in our next Call for Proposals.
- > **Invest in a validated approach.** Our grant-making formula and programme approach - based on principles of transparency, independence, demand-driven, flexibility, partnership building, capacity building and strong programme design - have been validated by independent evaluations as contributing to effectiveness and impact.
- > **Join UN Women's frontline efforts to empower women-led CSOs** to advance gender equality and women's rights in the 2030 Agenda and achieve the Global Goals.
