Empowering women to participate fully in economic life across all sectors and throughout all levels of economic activity is essential to: build strong economies; establish more stable and just societies; achieve internationally-agreed goals for development, sustainability and human rights; improve quality of life for women, men, families and communities; and propel businesses' operations and goals.

Procurement practices and the value chain provide a key opportunity for business to empower women. However, business policies and practices often overlook gender. In particular, economists increasingly acknowledge the contribution that women-owned businesses make to the growth of the global economy. Yet, this resource is hardly tapped by the private sector. It is estimated that the top 13 multinational corporations that purchase over \$1 billion each year from various suppliers, spend only 2.2% on women-owned businesses.

This interactive event will explore the benefits of and challenges to engaging women in global value chains from a range of perspectives and looks at the application of the global Women's Empowerment Principles in this context. In particular, participants will consider the relevance of Principle 5, which calls on businesses around the world to implement enterprise development, supply chain and marketing practices that empower women.
